2016 IN REVIEW

Our annual "Star Party was held on Dec. 1st with frigid weather but excellent viewing conditions. The Northshore Astronomy Club members were present with a variety of telescopes. 18 people braved the cold, clear night at Sunny Meadow Farms to enjoy the instructive viewing.

The Winter Fest walk enjoyed it's second year in a row to Bartlett Woodlot as the trail to Skunk Island was unfrozen and boggy as it was last February. 60 adults and children turned out to hike the trail and hear about winter identification of trees (mostly by their bark), and the history of the old mill pond and dam, and Harriet Bartlett's summer cottage site. A campfire and s'mores at Bartlett Park was an enjoyable end of the walk.

17 large, dead ash trees, and other species were removed near the entrance to Bartlett Woodlot as they were a safety hazard.

We donated \$1,000 to the Chelmsford High School Scholarship Fund for the use by a college bound student majoring in the general area of ecology or environmental studies.

The Conservation Restriction for Sunny Meadow Farms was returned by the State and recorded in the Middlesex Registry of Deeds in Lowell on October 6, 2016. The Baseline Report for the property should be completed in the next week or two. It has been a time consuming process with 3 consultants from Audubon having worked on the Baseline.
