(the Trust) solicits support at all our public invited events and meetings. We have an annual mailing for membership renewal concurrent with our Annual meeting in May and solicit donations and new memberships at all our meetings and outdoor events. The membership dues are nominal and were raised in 2019 for the first time in 20 years to the following: individuals (\$25.00), Seniors/students (\$15.00), families (\$40.00), sustaining (\$150), Benefactor (\$500) and Founding Circle member (\$1,961). We have sent membership and informational mailings to all the residents of Chelmsford twice in the past 20 years. In recent years, the number of members fluctuates within a narrow range. We have partnered with other non-profit and conservation organizations in our region of the state to provide programs of common interest to the public. These programs are environmental and conservation oriented. They offer a variety of seasonal outdoor activities to appeal to a broad range of public interests, such as bird watching, wildflower and tree identification, and star gazing. We also work with Chelmsford Town government on Conservation Restrictions to protect open space. The Chelmsford Land Conservation Trust, Inc. governing board is composed of 11 Directors from the Chelmsford area serving 3-year staggered terms and meet once a month throughout the year. Of these directors, 4 are officer positions with one-year terms: president, vice-president, treasurer, and secretary. Election of Directors takes place in May of each year at the Annual Meeting of the membership. The directors elect the Officers following the Annual meeting. Due to Covid restrictions all board meetings have been held virtually since March 2020.
